

# **DEED OF ADDITION RETIREMENT AND REMOVAL OF TRUSTEES**

#### Important Information

You should use this form only if:

 One or more of your trustees wish to retire, and are being replaced by the same number of trustees. You will need to tick box A in section 6.

Or

One or more of your trustees wish to retire, and they are not being replaced but there
will be at least two trustees including the Policyholder. You will need to tick box B in
section 6.

Or

 You wish to appoint additional trustees and the total number of trustees will be no more than 4. You will need to tick box C in section 6.

Or

 You wish to remove one or more of your trustees and replace them with the same number (or more) of new trustees for one of the following reasons: (i) They have died; (ii) They have lost mental capacity; (iii) They are refusing to act or cooperate in their trustee role; or (iv) They have remained outside of the UK for 12 months. You will need to tick Box D in section 6.

Or

 You are unable to locate one of the Trustees despite making all reasonable efforts to contact them and now wish to discharge them as a Trustee. There must be at least two trustees other than the missing trustee remaining. You will need to tick Box E in section 6.

If your circumstances are not covered by one of the five situations described above, then this form is not suitable for you and you should seek independent legal advice.

Please be aware that these notes are intended for general guidance only and should not be relied upon in place of specialist legal and tax advice.

During the life of the Policyholder, there must be at least one trustee and there should be no more than four trustees in addition to the Policyholder.

If an outgoing trustee is living and has mental capacity, they should resign and cooperate by signing this form.

However, if the outgoing trustee refuses to cooperate, it is possible for the remaining trustees to remove them without their consent. If you are in any doubt whether this applies to your situation, you should seek specialist legal advice.

If one of the trustees is being removed for the one of the reasons stated (i) to (iv), they do not need to execute (sign) this form but you still need to complete their details at section 3.

The Outgoing Trustees named in section 3 wish to retire or are being removed by the Continuing Trustees for one of the following reasons: (i) They have died; (ii) They have lost mental capacity; (iii) They are refusing to act or cooperate in their trustee role; or (iv) They have remained outside of the UK for 12 months.

The Trustees (or the Continuing Trustees alone in the case of the removal of a trustee) wish to appoint the New Trustees (see section 5), to take the place of the Outgoing Trustees (if any) as trustees of the Life Policy Trust.

It is intended that the property settled in the Life Policy Trust shall be transferred to or under the control of the Continuing Trustees and the New Trustees.

The Continuing trustees have made all reasonable efforts to locate the Missing Trustee named in section [4] and now wish to discharge the Missing Trustee as trustee.
